INTRODUCTION

We at NTN Buzztime, Inc. and its affiliated companies and subsidiaries (collectively "**Buzztime**," "**we**," "**us**," "**our**") are dedicated to protecting your privacy and handling your personal information with care and respect. We've tried to keep it as simple as possible, but if you are not familiar with terms like cookies, IP addresses, and browsers, then read about these key terms first. Your privacy matters to Buzztime so whether you are new to Buzztime or a long-time user, please take a moment to know our policy and if you have any questions please contact us (<https://www.buzztime.com/business/privacy-policy#contact>).

This Privacy Policy ("**Privacy Policy**" or "**Policy**") applies to our websites (buzztime.com (<https://www.buzztime.com>), buzztime.com/business (<https://www.buzztime.com/business/>), stumptrivia.com (<https://www.stumptrivia.com>), questionnairey.com (<http://www.questionnairey.com>), digital.stumptrivia.com (<https://digital.stumptrivia.com>)), to the Buzztime services and content we provide through businesses, networks, mobile devices, mobile applications, and to websites operated by our partners, as well as any other websites or services where this Policy is posted (collectively, the "**Services**"). This Policy describes the ways we collect, store, process, transfer, share and use data that identifies or is associated with you ("personal information") in connection with your use of the Services.

For your convenience, information relating to our use of cookies and similar technologies is set out below in our Cookie Policy. The Cookie Policy forms part of the Privacy Policy, and whenever we refer to the Privacy Policy, we are referring to the Privacy Policy incorporating the Cookies Policy.

Before registering for, installing and/or using our Services, please ensure that you have read and understood how we collect, store, process, transfer, share and use your personal information. NTN Buzztime, Inc. is the data controller of the personal information we hold about you.

We may change this Policy from time to time so please check back periodically for any changes to our Policy. When we change this Policy in a material way, we will update the last updated date above. Changes to this Policy are effective when they are posted on this page. Your use of the Services constitutes your agreement to this Policy (including the Cookies Policy) and to our Terms of Services and to any changes.

PERSONAL INFORMATION WE COLLECT ABOUT YOU AND HOW WE USE IT

Information You Provide to Us:

We collect personal information that you voluntarily submit directly to us when you use our Services. This can include information you provide to us when you register for our Services, fill in an online form requesting information related to our Services, create or edit your user account, correspond with us by phone, SMS, e-mail or otherwise, respond to trivia questions, or use some other feature of our Services. Such information may include, but is not limited to your first and last name, mailing address, e-mail address, telephone number, birth date (in order to ensure that you are old enough to use our Services), and ZIP or postal code where you live. In order to register for some Services, you may be asked to create a display name, username, and password. We will indicate to you where the provision of certain personal information is required in order for us to provide you certain features of the Services. If you choose not to provide such personal information, we may not be able to provide the Service to you or respond to your other requests. In addition, you may also be asked to provide certain demographic information, including your gender, education, income level, marital status, and race. You are not required to provide any demographic information in order to register for or use our Services.

Information We Automatically Collect from You:

There is certain personal information that we collect automatically as a result of your use of the Services. This information includes but is not limited to how you access and use the Services and information about the device you use to access the Services as further described in this Policy.

The tables in Appendices A and B summarize the categories of personal information we collect about you and how we use that information, as well as the legal basis which we rely on to process the personal information. We may link or combine the personal information you provide us with the information we collect automatically. This allows us to provide you with a personalized experience regardless of how you interact with us. We may anonymize and aggregate any of the personal information we collect (so that it does not directly identify you). We may use anonymized information for purposes that include testing our IT systems, research, data analysis, improving our Services, advertising and developing new products and features. We may also share such anonymized information with others. We will store the personal information we collect about you for no longer than necessary for the purposes set out in Appendices A and B and in accordance with our legal obligations and legitimate business interests.

HOW YOUR INFORMATION IS USED AND SHARED

Information you provide or that we collect automatically may be used by Buzztime, our agents, business partners, or service providers who process information on our behalf to provide the Services to you. If you elect to receive promotional communications during your registration process, we may also use information collected from you to contact you about the Services or other products or services that may be of interest to you (including special offers and promotions), to fulfill or respond to your requests, to send service notifications, to improve and personalize the Services, to conduct research, to solicit your feedback about the Services, and to deliver contextual and tailored advertisements on or through the Services. Information we collect may be combined with information collected from other sources (e.g., business partners) so that we may further improve the Services and to offer products and services to you and to improve the relevance of advertisements delivered on or through the Services. You may opt-out of receiving promotional communications from Buzztime at any time by visiting www.buzztime.com/editinfo and updating your communication preference settings in your account, or clicking the unsubscribe link at the bottom of the communication.

Buzztime may use information to enter you into contests or sweepstakes in which you choose to participate, give you status updates on contests, notify contest winners, verify contestant eligibility, and award prizes. Your information may be provided to third parties who sponsor and/or administer our contests, sweepstakes, and prize redemptions, or provide you with other services in connection with such contests or sweepstakes. For each contest or sweepstakes, we will provide notice of the applicable rules and if necessary, post any supplemental privacy provisions. To the extent there is a conflict between those privacy provisions and this Privacy Policy, the privacy provisions for the specific contest or sweepstakes will govern but solely to the extent of the conflict.

Our Services include interactive features that allow you to submit and share text, photos, links and other content (collectively, "**User Content**"). User Content that you submit to Buzztime or share using the Services becomes publicly available and can be seen, collected and used by others. In addition, certain user profile information is shared on the Services. Registered users are displayed by player ID or username along with information about location(s) where you play Buzztime games. If you add a Buddy or invite a friend to join Buzztime, an email will be sent on your behalf and will come from the email address and full name on your account. You may also receive messages from other users through the Services. Buzztime is not responsible for the content of such messages.

RECIPIENTS OF YOUR PERSONAL INFORMATION

As further set forth herein, we may share your personal information with the following (as required in accordance with the uses set out in Appendices A and B):

- **Service providers and advisors:** We may share your personal information with third party vendors and other service providers that perform services for us or on our behalf, which may include providing payment, email or chat services, fraud prevention, web hosting, or providing analytic services.
- **Business Partners:** Buzztime may share information with other businesses and partners to assist us in promoting our products and

services, or so that they can send you information about their own products and services, including special offers and promotions. For example, if you register with Buzztime through one of our partners, we may share the information you provide (including but not limited to your e-mail address and ZIP code) with the partner through whom you reached us. Our partners may use that information to contact you about their own products and services, or for other reasons. - **Purchasers and third parties in connection with a business transaction:** Your personal information may be disclosed to third parties in connection with a transaction, such as a merger, sale of assets or shares, reorganization, financing, change of control or acquisition of all or a portion of our business.
- **Law enforcement, regulators and other parties for legal reasons:** We may share your personal information with third parties as required by law or if we reasonably believe that such action is necessary to (i) comply with the law and the reasonable requests of law enforcement; (ii) detect and investigate illegal activities and breaches of agreements, including our Terms of Service; and/or (iii) exercise or protect the rights, property, or personal safety of our Services, its users or others.

LOCATION INFORMATION

When using our mobile applications or visiting our website, we may collect mobile device information like operating system, hardware type, numbers and/or codes unique to such device, device information, the location of your device, and app usage information. We may collect and process information about your actual location. We use various technologies to determine location, including, but not limited to IP address, GPS, and other sensors.

COMMUNICATIONS WITH US

We may communicate with you via push notification, email, SMS, MMS or other text message (to the extent you permit us to do so), and we may collect information regarding such communications, such as confirmation you have opened the email, read a message, or received a push notification.

STORING AND TRANSFERRING YOUR PERSONAL INFORMATION

Security.

We have security measures in place designed to help protect your personal information under our control against accidental or unlawful destruction, loss, change or damage. All personal information you provide via our websites and devices will be protected by TLS encryption technology. The level of security measures vary based on the sensitivity of the personal information that we have under our control. Please be aware that, despite our efforts, no security measures are perfect or impenetrable, and we cannot guarantee the security of the information you provide to us. Please keep this in mind when disclosing any of your information via the Internet.

You should take reasonable steps to protect against unauthorized access to your password, computer, and web-enabled devices, among other things, by signing off after using a shared computer, inserting a password on your web-enabled device, choosing a password that nobody else knows or can easily guess, keeping your password private, and periodically changing your password. You should never share your log-in information with other. We are not responsible for any lost, stolen or compromised passwords, or for any activity on your account via unauthorized password activity.

Consent to International Transfers of your Personal Information.

Buzztime and our Services are operated in the United States and are governed by United States law. If you are a resident of the European Union or other location outside the United States, please be advised that any information you provide through the Services will be transferred to the United States or other designated locations outside of the United States for certain processing/hosting operations. By using the Services, you consent to this transfer and to the use of the information as described herein. For avoidance of doubt, this may mean that your personal information will be stored in a jurisdiction that offers a level of protection that may, in certain instances, be less protective of your personal information than the jurisdiction you are typically resident in. We will take reasonable steps to ensure that your personal information is treated securely and in accordance with applicable law and this Policy.

YOUR RIGHTS IN RESPECT OF YOUR PERSONAL INFORMATION

In accordance with applicable privacy law, you have the following rights in respect of your personal information that we hold:

- **Right of access.** You have the right to obtain:
 - confirmation of whether, and where, we are processing your personal information;
 - information about the categories of personal information we are processing, the purposes for which we process your personal information and information as to how we determine applicable retention periods;
 - information about the categories of recipients with whom we may share your personal information; and
 - a copy of the personal information we hold about you.
- **Right of portability.** You have the right, in certain circumstances, to receive a copy of the personal information you have provided to us in a structured, commonly used, machine-readable format that supports re-use, or to request the transfer of your personal data to another person.
- **Right to rectification.** You have the right to obtain rectification of any inaccurate or incomplete personal information we hold about you without undue delay. You can update your registration information at any time by signing in to your account at www.buzztime.com/editinfo.
- **Right to erasure.** You have the right, in some circumstances, to require us to erase your personal information without undue delay if the continued processing of that personal information is not justified.
- **Right to restriction.** You have the right, in some circumstances, to require us to limit the purposes for which we process your personal information if the continued processing of the personal information in this way is not justified, such as where the accuracy of the personal information is contested by you.

- **Right to object.** You have a right to object to any processing based on our legitimate interests where there are grounds relating to your particular situation. There may be compelling reasons for continuing to process your personal information, and we will assess and inform you if that is the case. You can object to marketing activities for any reason.

YOUR CALIFORNIA PRIVACY RIGHTS

California law permits visitors who are California residents to request certain information regarding our disclosure of personal information to third parties for such third parties' direct marketing purposes. THIRD-PARTY SITES OR SERVICES

The Services may include advertisements and links to other sites. By clicking on an advertisement or link, you may be directed to third-party sites or services. These third-parties may collect information from and about you. These third-parties are not covered by this Policy, and Buzztime is not responsible for their privacy practices, the content of their sites, or their products or services. These third parties may have their own privacy policies, terms or statements and we encourage you to learn their practices before providing information. We may also use third parties to provide

advertisements, or to monitor certain parts of the Services for the purpose of reporting website traffic, statistics, advertisement click-throughs, or other activities. Furthermore, if you choose to log in, access or otherwise connect to the Services, or contact us, through a social networking services (e.g., Facebook), we may collect your user ID and username associated with that social networking service, as well as any information you make public using that social networking service. We may also collect information you have authorized the social networking service to share with us (such as your user ID, public profile information, email address, birthday, friends list, and page you have “liked”).

CHILDREN UNDER 13

COOKIE POLICY

This Cookie Policy forms part of our Privacy Policy and should be read together with it.

Like most companies, when you interact with our Services, we and our service providers may use cookies and other tracking technologies for storing information, including pixels (also known as a “web beacon” or “clear GIFs”), local storage, and device identifiers, to help provide, protect, and improve our Services. For example, to save your preferences, personalize content, target ads based on your interests, combat fraud and abuse, and streamline the functioning of and your access to this website.

This policy explains how and why we use these technologies and the choices you have. We use “cookies” and “similar technologies” interchangeably to refer to all of these technologies.

WHAT ARE COOKIES?

Cookies are small text files placed on your computer, phone, or other device when you visit websites and are used to record information about your activity, including the pages you view, the content you listen to, ads you click on, your settings, and other actions you take on this website.

Cookies can be “persistent” or “session” cookies. Persistent cookies stay on your device for a set period of time or until you delete them, while session cookies are deleted once you close your web browser.

SIMILAR TECHNOLOGIES

We use other data collecting technologies with similar functionality as cookies, including pixels, local storage, and device identifiers. While the specific names and types of cookies we use may change from time to time as we improve and update our Services, we have provided some basic definitions in order to help you better understand our Cookie Policy.

- **Pixels** – A pixel is a small amount of code on a web page or in an email notification that typically work in conjunction with cookies to identify our users and record user behavior. As many services do, we use pixels to learn whether you’ve interacted with certain web or email content. This helps us measure and improve our services and personalize your experience.
- **Local Storage** – Local storage is an industry-standard technology that allows a website or application to store information locally on your computer or mobile device. We use local storage, including HTML5, to customize what we show you based on your content consumption and other past interactions with this website.
- **Device Identifiers** – We also use mobile device identifiers for the same purposes articulated in this Cookie Policy, for example to recognize your device when you return to using our Services.
- **Software Development Kits** – We may use third parties including our service providers and business partners who use mobile SDKs to collect information to recognize your device when you return to using our Services. We may use this technology, for instance, to analyze how you interact with our websites and to enable analytics or other features through mobile devices.

HOW WE USE COOKIES

While we use cookies to deliver, measure, and improve our Services in various ways, the cookies we use generally fall into one of the following categories:

- **Operational** - These cookies are necessary to allow us to operate our Services as you have requested. For example, they let us authenticate your account and recognize what type of visitor you are, so we can provide you with the Services you requested.
- **Security/Abuse** - These cookies enable and support our security features, and help us detect malicious or unauthorized activity. We also use cookies to combat activity that violates our policies or otherwise degrades our ability to provide our Services. Cookies also help us fight spam and phishing attacks.
- **Functional/Preferences** - These cookies let us operate certain functions of our Services in line with the choices you make. These cookies enables us to remember you in-between visits. For example, when you continue to use or come back to our Services, we will remember your settings. Deletion of these types of cookies may result in limited functionality of our Services.
- **Performance/Analytics** - We use these cookies to monitor and assess how our Services are performing and where it can be improved.
- **Personalization** - These cookies use information about your use of our Services, such as the pages you visit or your response to emails, so we can recommend content that are more relevant and interesting to you based on criteria like your profile and activity on this website. We may also use these cookies to improve reporting on campaign performance, determine how many times people who click on ads end up taking an action (such as requesting information).
- **Buzztime Marketing** - We also work with third party business partners (as further explained below), such as Google, to track user activity and market our Services by showing you personalized ads for Buzztime Services on third party websites and applications.

THIRD PARTY COOKIES, ADVERTISING, AND DO-NOT-TRACK

Online Analytics Providers:

To help us better understand your use of the Services, we may use third-party analytics on our Services, such as those of Google Analytics. These third parties use cookies, web beacons and similar technologies to help us analyze how users use the Services, including by noting the third-party website from which you arrive. The information (including your IP address) collected by the applicable technologies will be disclosed to or collected directly by these service providers, who use the information to evaluate your use of the Services and share that information with us.
