

## OFFICIAL RULES 2018 BUZZTIME SMARTEST BAR™ CONTEST

**End Date:** 6:30 p.m. PT, September 12, 2018

**Promotion Period:** Promotion starts on the Start Date and runs through the End Date (“Promotion Period”). The entire Promotion Period consists of seven (7) separate entry periods (each an “Entry Period”). Each Entry Period begins at 5:30 PM PT/ 8:30 PM ET and ends an hour later on the same calendar day. Each Entry Period will have a Featured Category as shown below. The championship round will be held during Period 7 as described more fully herein.

Preliminary leaderboard is published after each Entry Period. The official leaderboard shall be released seventy-two (72) hours following each Entry Period. **First Place Location Prize:** One (1) Large Trophy, twenty-five (25) Player Gift Bags, twenty-five (25) Gold Medals, and American Express<sup>1</sup> gift card(s) in denominations determined by Sponsor in the total amount of one thousand (\$1,000.00 USD) dollars to be used towards a party sponsored by Buzztime at the winning Location for Eligible Participants. **Second Place Location Prize:** One (1) Medium Trophy, twenty-five (25) Silver Medals, and American Express gift card(s) in denominations determined by Sponsor in the total amount of five hundred (\$500.00 USD) dollars to be used towards a party sponsored by Buzztime at the winning Location for Eligible Participants. ARV not to exceed \$805.00 USD.

**Third Place Location Prize:** One (1) Small Trophy, twenty-five (25) Bronze Medals, and American Express gift card(s) in denominations determined by Sponsor in the total amount of two hundred and fifty (\$250.00 USD) dollars to be used towards a party sponsored by Buzztime at the winning Location for Eligible Participants. ARV not to exceed \$525.00 USD.

**TOTAL ARV:** Total ARV of all available prizes is \$3,295.00 USD.

**HOW TO PLAY:** During the Promotion, to enter:

**LOCATION ENTRY:** During each Entry Period, eligible Locations may participate by encouraging Eligible Participants to play Buzztime Smartest Bar Trivia Game (the “**Game**”) at their respective Locations on Entry Period Dates. Participant must be a Buzztime PlayersPlus<sup>®</sup> member for his/her score to qualify. Participant can sign up for a PlayersPlus account through (i) Buzztime entertainment devices at participating Locations, or (ii) online at <http://www.buzztime.com/play>. PlayersPlus registration is free. Participant must sign in using his/her PlayersPlus account and play the Game on Buzztime authorized devices at participating Locations for his/her score to qualify for the Location. Authorized devices include the Buzztime Playmaker<sup>®</sup> device, Buzztime Tablets, and Buzztime Mobile Playmaker<sup>2</sup> device. Registration is not required to play the Game, but is required for score to count toward Location’s overall placement. A link to these Official Rules shall be presented at the start of the Game at participating Locations. No purchase is necessary to sign up for the Game or to enter the Promotion. **No money or other thing of value may be collected, charged, contributed or exchanged as a condition of play or participation in the Promotion.**

**HOW TO WIN:** The Promotion Period consists of seven (7) Entry Periods (“**Period(s) 1-7**”).

**QUALIFYING ROUNDS (ENTRY PERIODS 1-6):** Championship week will consist of the top ten (10) Locations competing for the title of Buzztime’s Smartest Bar during Period 7. Weekly Location Score is used to determine the top ten Locations. The Weekly Location Score is based on the **average** of the top five (5) highest individual scores at the Location during each respective Period. The best five (5) out of six (6) Weekly Location Scores are added together to determine Location’s ranking among all Eligible Locations. In the event of a tie, the tiebreaker will be the Location’s six (6) week cumulative score in the Featured Category.

**CHAMPIONSHIP ROUND (ENTRY PERIOD 7):** Championship week will consist of the top ten (10) Locations. The **average** of the top five (5) highest individual scores at the Location during Period 7 will determine Buzztime’s Smartest Bar. In the event of a tie, the tie breaker will be the Location’s individual’s highest score.

**NOTIFICATION:** Potential winners will be notified by Administrator via email, phone or mail within fourteen (14) business days of the announcement with instructions on how to claim its prize. If potential winner cannot be contacted, fails to return any and all requested documentation, or is declared ineligible by Sponsor or Administrator, in their sole discretion, within ten (10) days, it will forfeit the prize in its entirety.

**ODDS OF WINNING:** This is a game of skill; winning is determined by the relative skill of the players.
